Dr. Kleissner co-founded <u>Toniic</u>, a global network for impact investors and Toniic's <u>100% Network</u>, a global group of asset owners dedicated to 100% impact, currently representing over \$6 billion in assets that are actively moving into impact.

Dr. Kleissner serves as a full member of <u>The Club of Rome</u>, as Chairman of the Board at <u>ImpactAssets</u>, on the Board of the <u>Schwab Foundation for Social Entrepreneurship</u> and <u>Proof of Impact</u>, and on the Advisory Board of <u>Chi Impact Capital</u>, <u>Industree Foundation</u>, <u>Impact Hub</u> Tirol, MCI Business School, Commonland, 4L Capital and Rainfall.
